Elderly Exploitation and Abuse Resources

This document was created to help members of our community who care for, interact with, or can personally be described as our most vulnerable adult citizens. This includes the elderly population within Pasco County, as well as disabled adults. Below is a list of agencies who can assist in providing services for victims and their families, to include referral services and caregiver support.

- **Pasco Sheriff's Office-Victim Advocates (VAs)**
 - The Pasco Sheriff's Office VAs are equipped to help victims of crimes identify and navigate available resources to assist them and their families. The VAs help ensure the victim attends any court related appointments required by the State Attorney's Office. The VAs can provide or arrange transportation to and from the court house.

- **Area Agency on Aging of Pasco-Pinellas, Inc. (AAAPP)**
 - The Area Agency on Aging of Pasco-Pinellas, Inc. will provide seniors, adults with disabilities, and caregivers with the resources and services needed to maintain independence, promote healthy aging and live an optimal quality of life. The Area Agency on Aging of Pasco-Pinellas, Inc. provides resources such as transportation, nutrition, case management, caregiving, and more.

- Caregiver Support: Offer supportive services for the caregiver such as day services, assist in providing incontinent supplies (because at times the cost is high)
 - Referral Assistance: Assist in getting services in the home such as homemaker services. Examples: Meals on Wheels, Housekeeping, Chore Services (assist in situations such as hoarders), food pantries
 - Insurance Assistance: Partners the vulnerable adults with the SHINE Program (Serving Health Insurance Needs of Elders) to help them find low or no cost prescriptions, help them know which Medicaid plan to select, help prevent them from becoming a victim of Medicare/Medicaid Fraud (See below agency description and contact information).

 - The Florida Department of Elder Affairs focuses on promoting the well-being, safety, and independence of Florida's seniors, their families, and caregivers. The Department provides most direct services through its Division of Statewide Community-Based Services, which works through the state's eleven Area Agencies on Aging and local service providers to deliver essential services to a vital segment of the population. The Department also directly administers a wide range of programs, ranging from the Long-Term Care Ombudsman Program, Office of Public and Professional Guardians, and Communities for a Lifetime to SHINE (Serving Health Insurance Needs of Elders) and CARES (Comprehensive Assessment and Review for Long-Term Care Services). - **National Family Caregiver Support Program (NFCSP)**

- Provides support for unpaid caregivers of persons 60 years or older. The goal is to relieve the emotional, physical, and financial hardships of providing 24 hour care.

- **Seniors versus Crimes (SVC)**

- The Primary Goal of the Seniors Vs Crime Project is to reduce the victimization of senior citizens who are often targeted for specific crimes or scams based on their age. The Project accomplishes this goal by providing various educational and crime prevention programs to senior citizen groups; investigating complaints and



seeking restitution for seniors in appropriate instances and by providing investigative agencies with senior volunteers to assist them with specific investigations.

- The Seniors vs. Crime Project does not handle criminal cases. When there is reason to believe that a violation of a criminal law has occurred, the entire case is transitioned to a Law Enforcement Agency. In some of these cases, investigating officers can request that a “Senior Sleuth” continue working on certain aspects of the non-criminal elements of the investigation. Under these circumstances, the Senior Sleuths are assisting law enforcement and provide all of their findings to the investigating officer. (There is no office in Pasco County).

- **Serving Health Insurance Needs of Elders (SHINE)**
 - SHINE (Serving Health Insurance Needs of Elders) is a free program offered by the Florida Department of Elder Affairs and your local Area Agency on Aging. Specially trained volunteers can assist vulnerable adults with their Medicare, Medicaid, and health insurance questions by providing one-on-one counseling and information. SHINE services are free, unbiased, and confidential. The SHINE program supports the Florida Department of Elder Affairs’ mission by providing free and unbiased health insurance counseling through a dedicated network of volunteers, empowering Florida seniors to make informed health care choices.
