TRAUMA SCENE CLEANING

The Pasco Sheriff's Office Victim Advocate Unit has compiled a list of trauma scene cleaners who hold permits through the Florida Department of Health. While not endorsing or recommending a particular company, the Better Business Bureau and Department of Health are contacted to verify their business status as well as if any complaints have been received. Citizens should consult their homeowner's insurance company as coverage for the services may apply. If the decedent was a victim of homicide or suicide where cleaning is needed, please contact our office to obtain victim compensation information.

Our Victim Advocate Unit strongly recommends that family or friends of the victim should not be involved in the cleaning process as this may further traumatize the survivors.
